As per the order read as 6<sup>th</sup> paper above, the Honourable Kerala Administrative Tribunal while disposing the OA 372/2019 filed by Smt. Prathibha.N, Staff Nurse Gr I, IMCH Kozhikode, has ordered to take a decision in the representation filed by Smt. Prathibha.N to restore her seniority in the Staff Nurse Gr I seniority list.

Smt. Prathibha.N, while working as Staff Nurse Gr II availed Leave Without Allowance from 03/10/2013 to 01/10/2015 under Rule 88 Part I KSR for study purpose. As per the order read as 1<sup>st</sup> paper above, ratio promotion from Staff Nurse Gr II to Staff Nurse Gr I was made effective in MES. As Smt.
