The appointment is also subject to Rule 3 (c) of the General Rules of KS&SSR of 1958.

The candidates are therefore directed to report for duty before the Principals of Govt.Medical Colle ges noted as Annexure along with this order and with documents in original to prove their qualification s, age and with a certificate of Medical Fitness obtained from a Medical Officer not below the rank of a Civil Surgeon, Grade I within fifteen (15) days from the date of receipt this order, failing which their appointment order shall stand cancelled. Original Community Certificate and Non Creamy Layer Certificate also should be produced before the Principal concerned for verification if the appointment is in reservat ion turn.

The Original One Time Verification Certificate which includes the scanned image of photo and signa ture of the candidates will be forwarded to the Principals of the institutions concerned where the candidates are posted. The photograph and the signature of the candidate should be verified and the fact should be recorded by the Principals concerned on the original One Time Verification Certificate itself. If there is any discrepancy, the candidate will not be allowed to join duty and the fact should be reported to this office forthwith.

The candidates are also directed to produce the prescribed Pro-forma, a copy of which may be obtained from the Principal duly filled up before they actually join duty. The station posted in this ord er is subject to change since General Transfer – 2020 norms are in force.
