ORDER No. G4 /2945/ 2020 /DME Dated: 15/06/2021

The provisional Seniority list of faculties in the cadre of Assistant Professor, Department of Orthodontics under Medical Education Service has been published, as per the circular read as 4rd paper above.

The last date fixed for submitting complaints, if any, was on 26-02-2021. The following complaints received with in the above date.

Dr.Mukundan.V, Assistant Professor, Government Dental College, Alappuzha, as per his representation 6th read above, has informed that, there is no vigilance case initiated against him, there was a departmental enquiry conducted against him based on the direction of the vigilance. He has requested to remove the statement in the Provisional seniority list that, "Vigilance case finalised".

This has been verified with the records kept in this office and decided to correct the wording as "Complaint received through VACB".

Dr.Manjith Rajan, Assistant Professor, Government Dental College, Thiruvananthpurtam, as per the representation 8th read above, has informed that, he and Dr.Sreehari.S (Sl No.3 in the Provisional list) has been appointed as Senior Lecturer in Medical Education Service in the same advice, in which Dr.Manjith Rajan has the seniority. But, he has been put junior to Dr. Sreehari.S, in the provisional seniority list and he has requested to correct the mistake and place him in the actual position.

This has been verified with the records kept in this office and found that, Dr.Manjith Rajan and Dr.Sreehari.S had been advised to the post of Senior Lecturer in Orthodontics, as per the advice read as 1st paper above, in which, Dr.Manjith Rajan had been placed as serial

number (1) and Sreehari had been placed as serial number (2). Both of them have not availed extension of joining time. Moreover, as per the Government letter read as 2nd paper above, it is instructed that, 'the faculties who have been directly appointed as erstwhile Senior Lecturers or Assistant Professors, the seniority has to be fixed based on their date of PSC advice (Rule27(c))'. As such, Dr.Manjith Rajan is senior to Dr.Sreehari.S. Therefore, Dr.Manjith Rajan is placed as serial number (3) and Dr.Sreehari.S is placed as serial number (4) in the seniority list.

Dr.Sreehari.S, Assistant Professor, Government Dental College, Kozhikode, Dr.Manjith Rajan, Assistant Professor, Government Dental College, Thiruvananthpurtam, and Dr.Anand R Krishnan, Assistant Professor, Government Dental College, Thiruvananthapuram, as per the representations 7th to 9th read above, respectively, have submitted representation, stating that, Dr.Jayan James had availed leave without allowances and hence he had not completed the required after PG service, as per Rule 10 (ab), to get promotion to the cadre of Associate Professor. They have requested to change his seniority position as such.

These complaints have been scrutinised with the records in this office and Government directions received in this regard and it is found that,

In the Rule 10 (ab) of KS &SSR it is stated that;

"Where the special rules or recruitment rules for a post in any service prescribe qualification of experience, it shall, unless otherwise specified, be one gained by persons on temporary or regular appointment in capacities other than paid or unpaid apprentices, trainees and casual laborers in Central or State Government services or in public sector undertaking or Registered private sector undertaking, after acquiring the basic qualification prescribed for the post".

As per the letter read as 2nd paper above, Government have issued clarification in this regard as follows;

"ഏതൊരു വകുപ്പിലെയും സീനിയോരിറ്റി ലിസ്റ്റ് തയാറാക്കേണ്ട മാനദണ്ഡങ്ങൾ കെ എസ് & എസ് എസ് ആറിലെ ചട്ടം 27 – ൽ പ്രതിപാദിച്ചിട്ടുണ്ട്. രണ്ട് സ്കീമിലൂടെ erstwhile സീനിയർ ലക്ചറർ or അസിസ്റ്റൻറ് പ്രൊഫസർ തസ്തികയിൽ പ്രവേശിച്ചിട്ടുള്ളവരാണ് ദന്തൽ വിഭാഗത്തിലെ എല്ലാ അസിസ്റ്റൻറ് പ്രൊഫസർമാരുമെന്ന് കാണുന്നു. അതിനാൽ ദന്തൽ വിഭാഗത്തിലെ അസിസ്റ്റൻറ് പ്രൊഫസർ കേഡറിലെ സീനിയോരിറ്റി കെ എസ് & എസ് എസ് ആറിലെ ചട്ടം 27 (a) & (c) പിരിവുകൾ പ്രകാരമാണ് തയ്യാറാക്കേണ്ടത്".

As such, the eligibility and required service for promotion to the cadre of Associate Professor as per Rule 10 (ab) of KS &SSR will be calculated while preparing the DPC Note, on the occurrence of vacancy in the cadre of Associate Professor. This has been clarified in detail by the Government in the G.O(Rt) No.1797/2018/H&FWD dated.05-06-2018, attached along with representation 7th read above.

In this circumstances, the complaints 7th to 9th read above will not stand and considerable as per the rules in force. Hence, rejected.

The order of declaring probation of Dr. Sujith.B, in the cadre of Assistant professor has not included in the provisional seniority list, which is hereby entered.

The provisional seniority list in the cadre of Assistant Professor in Orthodontics is hereby finalised accordingly. The final seniority list is attached as Annexure-I.
