

#### ORDER

Smt.Jayanthi.M.R, Assistant Professor, Government College of Nursing, Kozhikode filed OA(EKM) 981/2021 before Hon'ble Kerala Administrative Tribunal, aggrieved by the seniority assigned as per 5th, 7th and 9th paper read above.

2.In the order dated 02.07,2021 in OA(EKM) 981/2021, read as 12th paper above, the Hon'ble Kerala Administrative Tribunal disposed the Original Application without going into the merits of the contentions directing the second respondent to consider and pass appropriate orders on Annexure-A8 representation in accordance with law and after affording an opportunity of hearing/virtual hearing to the applicant and other affected persons, if any, within a period of three months from the date of receipt of a copy of the order.

3.As directed by the Hon'ble Kerala Administrative Tribunal, a representative of Government heard the applicant and the affected persons on 28/09/2021. The representative of Director of Medical Education was also present.

4.Smt.Jayanthi. M.R entered Medical Education service in Director of Medical Education in the post of Lecturer on 07/12/1998 by transfer from the

post of Staff Nurse her service and also probation was regularized in the category of Staff Nurse. On 23/09/2006 she qualified M.Sc. Nursing. Hence as per pay revision dated 14/12/2009 read as 4th paper above, she was redesignated as Assistant Professor on that date. Her argument is that while she was appointed in DME, the cadre was Lecturer and the qualifications fixed was B.Sc. Nursing no priority was assigned to those who posess M.Sc. Nursing. The seniority was fixed as per PSC advice/date of joining according to KS&SSR Rule 27.

5.But later the post of lecturer in the entry cadre was abolished. With effect from 01/01/2006 those who possessed Nursing PG where re-designated as Assistant Professor. Smt. Jayanthi obtained PG on 23/09/2006. She has no complaint with regard to those teachers who obtained M.Sc. and who were promoted as Assistant Professors. Her claim is that she is entitled to original seniority because one lower post abolished and a higher post having higher qualification is introduced those who were continuing in the lower post is entitled for the protection of the seniority. This is done either by relaxation for the higher qualification or by providing suitable time to those persons they are in service for obtaining higher qualification but this was not done in this case. Smt. Jayanthi claims that this resulted in the loss of seniority to the seniors. She claimed that though she had entered service as Lecturer in the year 1998, She had not obtained cadre promotion. If the seniority as per the list published by the DME is approved she will not get any promotion since she will retire on superannuation within four years.

6.As per the conditions laid down by the Indian Nurses Council, a person who has 13 years of teaching service after obtaining PG is eligible for promotion as Associate Professor. At present Smt. Jayanthi M.R has got 15 years post PG teaching service. Her earlier non teaching service of 7 years and 9 months is also not taken into consideration. Her predecessors who had

obtained their PG. She has requested to instant the above benefit to her also.

7. The DME as per the circular read as 7th paper above, had published the seniority list for promotion to the post of Associate Professor, from the feeder category of Assistant Professor. Smt. Jayanthi claims that in the said seniority list, persons who were appointed in the lecturer post without PG where given seniority with effected from the date their advice. But since complaints were received against seniority list and based of various directions received from Government and the service of persons before obtaining PG was named as Sr. Lecturer/ Assistant Professor. The Seniority list which was revised as per the date which they got appointment in the category of lecturer. A revised seniority list was published as per the said circular.

8.The Committee which was constituted for examining the objections and the seniority list, on 07/05/2021 had recommend that with regard to SN.23 and SN.84 (Smt. Jayanthi and Smt.Beena) their non PG teaching service should also be considered as requested in the objections dated 27/4/2021. The DME conducted a Video Conference to these two teachers on 10/06/2021.

9.Smt. Beena who had entered Medical Education service by category change from the post of staff nurse in DHS had total service of 12 years and six months under DME in Nursing Tutor post. Smt. Jayanthi who entered in DME service in the year 1998 as lecturer without PG qualification had a total 8 years of non PG teaching service (in the post of lecturer). Both of them got appointment in the DME service in the entry cadre Tutor/Lecturer the qualification was B.Sc. Nursing. Smt. Beena obtained PG on January 2013 and Smt. Jayanthi obtained PG on September 2006 through lecture quota.

10. The entry cadre in Nursing Education was fixed as Tutor as per the order read as 1st paper above. The qualification fixed was B.Sc. Nursing and three years experience in Nursing field the appointment was made from among the Tutor in nursing colleges /Nursing Superintendent/ Sister/Head Nurse/ Staff Nurse from the DHS and in the absence of qualified persons by direct recruitments later as per G.O.(Ms) No.95/02/H&FWD dated 24/04/2002. The appointment of entry cadre Tutor/ lecturer was effected through Kerala Public Service Commission and the basic qualification was fixed as M.Sc. nursing. The following amendment where made to the order dated 24/02/2002 vide G.O.(Ms)No.190/2003/H&FWD dated 05/09/2003

"The name of tutor/lecturer in nursing colleges appearing in G.O.(Ms) No.95/02/H&FWD dated: 24/02/2002,read as 2nd paper above will be corrected and read as senior lecturers".

&

"The existing lecturers with P.G. will be re-designated as senior lecturers and paid Rs.10000-15200/-. The existing lecturers without P.G. will be continued as lecturers and they will be paid at the scale of Rs.8000-13500/-. They will be re-designated as senior lecturers as and when they acquire P.G. and will be paid accordingly".

When UGC scale was introduced, as per the order read as 4th paper above the entry cadre was fixed as Assistant Professor with effect from 1/1/2016 the lecture and Assistant Professors were having different scale of pay. Before the implementation of pay revision order dated 14/02/2009 the Nursing Teachers who were appointed as Tutor/Lecturer was given Assistant Professor Vide G.O.(Ms)No.428/1967/HLD dated 31/07/1967. The qualifications was as follows:

"M.Sc. Degree in Nursing and Total experience of 3 years in Nursing

of which one year should be after the acquisition of M.Sc. Degree in Nursing".

- 11.Promotions were made as per vertical seniority the teaching service in the entry cadre (lecturer) were also considered.
- 12. After hearing the petitioners and after perusing the Government decisions so far taken in this matter, the following facts are noted.

Rule 10 (ab) of KS&SSRs is related with considering the experience required for selection to a particular post for which Special Rules are in force. It states that the experience after acquiring the basic qualification should be taken unless otherwise specified in the Special Rules . It is not fair to determine the seniority taking into consideration of Rule 10 (ab) of KS&SSRs as this is only related with determining the experience only. Special Rules have not been formulated for the Nursing Education wing so far. In these circumstances, that the provisional seniority list published by the DME as per circular dated 07/04/2021 cannot be agreed to.It is seen that it was misinterpreted that the provisional seniority list published was as per circular dated 07/04/2021 The above said circular No.S2/173/2020/H&FWD dated 23/01/2021, was issued for the preparation of the seniority list in the dental wing only, there are sufficient grounds for implementing Rule 10 (ab) of KS&SSRs since there exists Special Rules and Dr.Marykutty Vs State of Kerala judgment wherein the court has made it clear that Rule 10 (ab) of KS&SSRs should be implemented in dental wing, has been not challenged by the Government. Letter No.S2/173/2020/H&FWD dated 23/01/2021 does not direct the DME that Rule 10 (ab) of KS&SSRs should be made applicable to the nursing wing also. Therefore, the statement of the DME that the seniority list published on the basis of the Government direction is false and baseless.

- 13. As per the Letter No.S2/38/2020/H&FWD dated 02/06/2020 read as 8th paper read above, Government had given direction to the DME on how to prepare the seniority list in the various streams in Medical Education Department. Government have made it clear that since the various court cases regarding the seniority disputes in the department are pending before the court, the seniority should be prepared following the guidelines as was done earlier. While preparing the seniority list in circular dated 07/04/2021, the DME has not followed the direction in the Government letter dated 02/06/2020. Even though the letter No.S2/38/2020/H&FWD dated 02/06/2020 has been stayed by the court in cases filed by the Medical doctors, there does not exist stay in the Nursing wing. This has been informed to the DME as per letter No. S2/14/2021/H&FWD dated 15/02/2021. While preparing the circular dated 07/04/2021, the DME has not taken into consideration this also. So the provisional seniority list published by the DME as per circular dated 07/04/2021 vide 9th paper above cannot be agreed to.
- 14. Government have filed affidavits in the seniority dispute cases before court stating that the lecturer seniority should be protected. Government filed affidavits as per the Government order read as 5th paper above wherein it has been made clear that seniority shall be decided according to Kerala Public Service Commission advice seniority/from the date of acquiring mandatory qualification as the case case may be. So the PSC advice seniority cannot be altered. If the Government takes a different stand, that will affect the pending court cases. Hence the provisional seniority list published by the DME as per circular dated 07/04/2021 vide 9th paper above cannot be agreed to.

15. Government have examined the matter in detail on the basis of the contentions raised by the applicant and the report of Director of Medical Education and connected documents available with Government and decided to cancel the Provisional seniority list published as per 9th paper above and Director of Medical Education is directed to publish the seniority list of Assistant Professor in Nursing Education wing as per the directions contained in the Government letter read as 8th paper above.

18. The Annexure-A8 representation in OA(EKM)No.981/2021 submitted by the applicant is disposed off as above and the direction of Hon'ble Kerala Administrative Tribunal in the order dated 02.07.2021 is complied with accordingly.
