**ORDER No.J2/3600/2018/DME Dated:07.04.2021**

As per this office order read as 1<sup>st</sup> paper above, the seniority list of Gr.II Staff Nurses,who have been integrated to the common Seniority List of Staff Nurse Gr-II in Medical Education Service from the Co-Operative Medical College, Ernakulam was finalised.

2.The names of above Staff Nurses have been inserted in between Rank No.85 and 86 in the previously existed Rank List of Staff Nurse Gr-II as in reference 3<sup>rd</sup> above and assigned their seniority as per rules.The incumbent with Rank No.86 in the list read as 3<sup>rd</sup> paper above was granted promotion to the cadre of Staff Nurse Gr-I w.e.f 21.05.2018.Hence,the Staff Nurses included in the seniority list read as 1<sup>st</sup> and whose probation in the cadre have completed successfully are eligible for promotion to the cadre of Staff Nurse Gr-I w.e.f from 21.05.2018,as their position in the seniority list is just above the rank No.86 in the list read in ref 3 who was promoted to the cadre of Staff Nurse Gr-I w.e.f 21.05.2018.
