The principal of each college should prepare a list of candidates appearing from their college in the serial order of Register No. of candidates and send it to the Chairperson with the following details of each candidate.

- (a). Duly filled new application form along with chalan receipt.
- (b). Duly filled hall ticket
- (c). Photocopy of front page of SSLC book bearing name of the candidate
- (d) Attested copy of mark list of D. Pharm part II examination (for those appearing subsequently).

Note- Each of the above-mentioned items (from "a" to "d") should be separately arranged for the entire batch of regular and supplementary students in the order of their Register Nos.
