Draft list of General Transfer of eligible Dental Hygienists has been issued vide Order read above. As per the draft list of General Transfer 2021, Smt. Rasminadh R S, Dental Hygienist has been transferred from Govt. Dental College, Thiruvananthapuram. Now, Smt. Saumya R (advance copy; not through General Transfer norms) and Smt. Rasminadh R S, Dental Hygienist has submitted representation with relevant treatment certificate to retain them in their present station.

2. Both the applications have been considered/examined on merit and in view of the conditions specified in the GO read above. Smt. Saumya R is not eligible to be retained in her present station, due to the lack of documents as specified in the Clause (ii) para 4 of the GO read above. More over, she is one of the senior most Dental Hygienist in Govt. Dental College, Thiruvananthapuram and has already completed more than five years of service in the same station (and continuing in the present station since 20/06/2008).

3. Smt. Rasminadh R S, Dental Hygienist is eligible to be retained in her present station as per Clause (i) para 4 of the GO, on compassionate ground.
