## **Notification**

Government of Kerala, vide G.O.(Rt) No.3005/2013/H&FWD dated 26.08.2013 has ordered the Director of Medical Education, Thiruvananthapuram to conduct a last and final Counselling for filling up the vacant MDS seats belonging to the State Quota reverted from Govt of India following the 4<sup>th</sup> Round of Counselling ordered by the the Honble Supreme Court of India, subject to the specific conditions(ii) to (vii) laid down by Govt in the said order as also G.O.(Rt) No.1666/2013/H&FWD dated 16.5.2013, ie; the Prospectus for Admission to MDS Courses, Govt of Kerala.2013. A copy of G.O.(Rt) No.3005/2013/H&FWD dated 26.08.2013 is posted in the website of DME & the Prospectus is available in the website of CEE for information.

Pursuant to this Govt Order, the last and final allotment for MDS Courses 2013, is scheduled to be held on **Friday the 30<sup>th</sup> August .2013**, at **9.00** am in the Directorate of Medical Education, situated in the Thiruvananthapuram Medical College campus. This will be for the vacant seats reverted to the State from AlQ, and for resultant vacancies that are likely to arise in Govt Dental Colleges & 50% seats in Self Financing Dental Colleges following exercise of higher option by the candidates.

The allotment for candidates will be strictly based on the rank list & category list published the Commissioner for Entrance Examinations (CEE) and subject to conditions of the Prospectus and further conditions specifically ordered by Govt in G.O.(Rt) No.3005/2013/ H&FWD dated 26.08.2013. Accordingly, CEE - rank holding candidates under all categories, ie; State Merit, SC/ST, SEBC etc are eligible to attend this final counselling **except those candidates admitted under All India Quota** and currently holding an AIQ seat as on 21.8.2013, the date of closure of AIQ admissions as per

Clause.XII of the Prospectus. Candidates who had opted out in the last two rounds of counselling are also eligible. The details of the vacant Specialty seats, reverted from AIQ to State Quota in Govt Dental Colleges, and the distribution of seats as per the reservation criteria in Clause.VI of the Prospectus is displayed in the web site of the Director of Medical Education, <u>www.dme.kerala.gov.in</u>.

Candidates now admitted for MDS in any Govt Dental College Or Self Financing Dental College shall invariably produce all Certificates prescribed in Clause.XI.C of the Prospectus, along with an NOC from the Principal of the Dental College where admitted. Further, candidates admitted in Self Financing Dental Colleges, shall produce an affidavit/letter stating that the Self Financing Dental College Management is willing to admit candidates from the Govt merit list in the resultant vacancies as per condition (iv) of G.O.(Rt) No.3005/2013/H&FWD dated 26.08.2013. Further, attention of Candidates are also particularly drawn to conditions (v), (vi), & (vii) of the said GO which will be scruplessly adhered to by this Office and is also binding on the candidates. Candidates securing admission in this Counselling, if already admitted, have to produce their T.C also before joining and in any case by the last date of closure of admissions ordered by the Honble Supreme Court of India which is 31.8.2013.

Candidates, at the time of Counselling, should file a declaration in the Declaration form available at the Counselling venue, as to the MDS seat if any held by them under AIQ/State, along with the Option form which will be provided. Furnishing false information or suppression of factual information to the admission authority will lead to summary expulsion from the counselling, and if discovered later will be bound to pay liquidated damages. Candidates can opt only for that Course/College for which vacancy exists at the time of counselling. Selection and allotment will be based strictly on the rank secured in the Entrance examination and subject to availability of seats. If a candidate is not able to attend the allotment process on genuine grounds, proxy at the risk of the candidate is

permissible on production of an authorisation letter as mentioned in the Prospectus.

The candidates are advised to have a close watch on the website of DME for further information and confirmation in the matter.
