As a consequence of filling up of the vacant seats in Govt Dental Colleges, and should seats become vacant under 50% Govt merit quota in Self Financing Dental Colleges, allotment will be made from the Govt rank list as per G.O.(Rt) No.3005/2013/H&FWD dated 26.08.2013

Notes:

1. \*Honble High Court of Kerala in WP© W.P.(C).No.18255/2013 (E) had ordered that the Petitioner be admitted provisionally, and in compliance of the order was admitted in GDC Kottayam in a General Merit seat in the Specialty of Periodontics. As a vacancy has now arisen in SEBC, and in the specialty of Periodontics as per the Prospectus rota, the said petitioner/candidate Dr.Anju is shifted from the General Merit seat occupied by her to the SEBC vacancy in the same specialty of Periodontics at GDC Kottayam. Consequently the merit seat vacated by her will become General merit. This will be subject to the confirmatory orders of the Honble High Court of Kerala.
2. The allotment for candidates will be based on the rank list & category list published the Commissioner for Entrance Examinations (CEE) and subject to the Prospectus Condition and further stipulations laid down by govt G.O.(Rt) No.3005/2013/H&FWD dated 26.08.2013.
3. Candidates can opt only for that Course/College for which vacancy exists at the time of counselling. Selection and allotment will be based strictly on the rank secured in the Entrance examination and subject to availability of seats.
4. Candidates have to submit a declaration that they are holding/not holding an MDS seat at the time of counselling. Candidates furnishing false information/suppressing factual information are liable to be summarily expelled from the Counselling process at the discretion of the Admitting authority.
5. Candidates attending the counselling will have to submit the preference form in the prescribed form indicating the College and Course, which they would like to opt, and submit the same at the time of allotment.

6. If a candidate is not able to attend the allotment process, proxy at the risk of the candidate is permissible on production of an authorisation letter as mentioned in the Prospectus.
7. Candidates who secure admission in Govt/ Self Financing Dental Colleges will have to remit the fees and join in the concerned College on or before 31.8.2013 by 5.00.pm .
8. Candidates having taken an admission memo and fails to join the said course, resulting in the seat remaining vacant as the date of closure of admission is 31.8.2013 is bound to pay the liquidated damages stipulated in the Prospectus.
