Notification

The final allotment for PG Dental (MDS) Courses 2012 is scheduled to be held on 30.06.2012 in the Directorate of Medical Education, situated in the Thiruvananthapuram Medical College campus. **The allotment for candidates will be based on the rank list, published by the Commissioner for Entrance Examinations (CEE) and will be for the four seats reverting to State Quota from AIQ, in the Government shown below.**

1. Govt. Dental College, Thiruvananthapuram - Three seats (3) in the specialities of

(a) Prosthodontics (b) Oral & Maxillofacial Surgery (c) Periodontics

2. Govt. Dental College, Kozhikode - One seat in the Speciality of Oral Pathology

Of these one seat is reserved for SEBC -Ezhava.

Following counselling to the seats in Govt. Colleges, subsequently from the seats becoming vacant in Self financing Dental Colleges. one seat will be allotted to Dr.Remya P Mohanan as per direction of the Hon'ble High Court of Kerala in WP©14107/2012 dtd. 21.06.2012 and if she opts, the MDS Prosthodontics seat allotted to her will be reallocated to General Merit candidate subject to the result of W.P.(C) 4196/12 .

Candidates wishing to attend the counseling will have to download the preference form in the prescribed format from the website "www.dme.kerala.gov.in". Candidates are required to fill in the College and Course, which they would like to opt, in the preference form and submit the same at the time of allotment.

Candidates can opt only for that Course/College for which vacancy exists at the time of counseling. Candidates who wish to continue in the already allotted course need not attend the final round counseling.

Selection and allotment will be based strictly on the rank secured in the Entrance examination and subject to availability of seats.

If a candidate is not able to attend the allotment process on genuine grounds, the parent/guardian, or any authorised person can act as proxy at the risk of the candidate. Such authorised person should produce an authorisation letter as mentioned in the Prospectus. Candidates have to produce the admit card of the entrance examination and fee receipt, NOC from the Principal of concerned colleges, in the case of candidates who have taken allotment in the previous counseling. The candidates those who have opted out in 1st round counseling can attend the final round counseling. But candidates who did not appear in the first round of counseling will not be considered in the final round of counseling.
