Notification

The first round allotment process of the PG Medical (MD/MS/Diploma) Courses 2012 is scheduled to be held from 09.04.2012 to 12.04.2012 in the Directorate of Medical Education, situated in the Thiruvananthapuram Medical College campus. Candidates included in the different reservation categories are also required to attend the counseling on the basis of their rank in the general category. The allotment for candidates other than service quota will be based on the rank list, which are likely to be published by the Commissioner for Entrance Examinations (CEE)

Candidates wishing to attend the counseling will have to download the prescribed format of preference form from the website "**www.dme.kerala.gov.in**". Candidates are required to fill in the college and course, which they would like to opt, in the preference form at the time of allotment.

Candidates can opt only for that course/college to which vacancy exists at the time of counseling. Only candidates who have appeared for the 1st round counseling will be eligible to appear for other round allotments.

Selection will be based on the rank secured in the entrance examination and availability of seats. If a candidate is not able to attend the allotment process on genuine grounds, the parent/guardian, or any authorised person can act as proxy at the risk of the candidate. Such authorised person should produce an authorisation letter as mentioned in the Prospectus. <u>Candidates have to produce the admit card of the entrance examination and the original</u> <u>certificates as mentioned in the Prospectus.</u>

Candidates who get selection in the counseling are required to report before the Principals of the concerned college on 20.04.2012.
