### **Notification**

The final round allotment process of the PG Medical (MD/MS/Diploma) Courses 2012 is scheduled to be held on 29.06.2012 and from 02.07.2012 to 06/07/2012 in the Directorate of Medical Education, situated in the Thiruvananthapuram Medical College campus. Candidates included in the different reservation categories are also required to attend the counseling on the basis of their rank in the general category.

Candidates wishing to attend the counseling will have to download the prescribed format of preference form from the website "[www.dme.kerala.gov.in](http://www.dme.kerala.gov.in)". Candidates are required to fill in the college and course, which they would like to opt, in the preference form at the time of allotment.

Candidates can opt only for that course/college to which vacancy exists at the time of counseling. Only candidates who have appeared for their first round counseling will be eligible to appear for final round allotment. Candidates those who had not attended their first round counseling, and those who had not joined in the allotted college and those who have discontinued the course after joining will not be considered for the final round counseling. Candidates who wish to continue the already allotted course need not attend the final round counseling.

Selection will be based on the rank secured in the entrance examination and availability of seats. If a candidate is not able to attend the allotment process on genuine grounds, the parent/guardian, or any authorized person can act as proxy at the risk of the candidate. Such authorised person should produce an authorization letter as mentioned in the Prospectus. Candidates have to produce the copy of admit card of the entrance examination and fee receipt, NOC from Principal of Concerned colleges in the case of candidate took allotment in the previous counseling. The candidate those who have opted opt out in 1<sup>st</sup> and 2<sup>nd</sup> round counseling can attend the final round counseling. Those candidates who have taken admission under state quota and then vacated to join AIQ will not be considered for the final round counseling.

Candidates who get selection in the counseling are required to report before the Principals of the concerned college on or before 09.07.2012.
