Notification

The final round allotment process for the vacancies/ arising vacancies of the PG Medical (MD/MS/Diploma) Courses 2011 under General Merit/ SC/ST/Other categories, including the 50% seats in self financing colleges, is scheduled on 28.06.2011 at 09.30 am in the Thiruvananthapuram Medical College auditorium (old). The details of available vacancies will be published in the website "www.dme.kerala.gov.in" after 26.06.2011. **All the candidates included in the rank list published by the Commissioner for Entrance Examinations can attend this counseling.** However those who had not attended the 1st round counseling, even after included in the counseling notification, and those who had not joined in the allotted college and those who have discontinued the course after joining will not be considered for the final round allotment. Candidates who wish to continue the already allotted course need not attend the final round counseling. Candidates who wish to attend the counseling will have to download the prescribed format of preference form from the aforesaid website.

Allotment will also be done to vacancies that may arise due to selection to higher options. Selection will be based on the rank and availability of seats. Unfilled seats under reservation categories will be converted to General Merit after the whole allotment of the respective quotas. So the candidates interested in the unavailed seats under reservation quotas are required to be present in the counseling hall till the whole procedure is completed.

Candidates will have to produce all the original certificates as mentioned in the Prospectus. However in the case of candidates, who had already secured admission in a Government Medical College in Kerala, documents substantiating their admission in that college shall be produced in lieu of the original certificates. Candidates who get allotment on 28.06.2011 will have to take admission on that day itself at the allotment centre. Such candidates will have to remit the required fees, as per Prospectus, in the allotment centre. However in the case of candidates who already got admission in Kerala, tuition fees will be adjusted.

Those who discontinue the course after the final allotment will have to pay the liquidated damages as mentioned in the Prospectus. Candidates who wish to relinquish the already allotted seat are required to submit the resignation before the final round allotment in order to avoid payment of liquidated damages.

The conduct of allotment to the 50% seats in self financing colleges will be subject to the direction of the High Court, if any, in the writ petitions filed in this regard. The fee for the self financing colleges will be per the Government order. The unfilled seats in self financing colleges, after the final allotment on 28.06.2011, will be surrendered to management quota.

Candidates are advised to have a close watch on the related information provided through the website.

The classes will commence on 01.07.2011.
