Notification

As per the PG Medical Prospectus 2011, applicants under Health Service Quota and Insurance Medical Service Quota should have completed a minimum period of 4 years service under Government of Kerala to become eligible to apply under service quota. Now Government vide G.O(Rt) No.2356/2011/H&FWD dated 24.06.2011, have relaxed the minimum qualifying service to one year in respect of service quota, subject to certain conditions.

Accordingly applications are invited from Health Service and Insurance Medical Service candidates who have either secured a place in the ranklist published by the Commissioner for Entrance Examinations based on the common entrance examination conducted on 09.02.2011 or qualified the separate entrance examination for service candidates conducted on 29.05.2011. Applicants should be regular staff under Health Service Department/Insurance Medical Service and should have completed a minimum period of one year service as on 05.01.2011 to become eligible to apply.

Application forms: Applicants are required to forward a photocopy /printout of the application form directly to the controlling officer concerned. There is no need to submit the application online. Only a photocopy of the earlier application submitted before the Commissioner for Entrance Examinations, need be forwarded to the controlling officer. In case photocopy of the application is not readily available with the candidate, they can access the website of the Commissioner for Entrance Examinations "<http://cee.kerala.gov.in/pgm2011/main/frame.html>" and take a printout of the existing application form.

The following should be attached along with the application form.

1. Demand Draft of Rs.1,000/- drawn from a Nationalized Bank in favour of the Commissioner for Entrance Examinations, payable at Thiruvananthapuram.
2. Service details by the Accountant General, Kerala issued after 05.01.2011.
3. Admit card issued by the Commissioner for Entrance Examinations. Candidates are required to denote their rank in the entrance examination on the top of the application form.

Last date and time for receipt of application forms: Candidates, seeking admission should forward the application along with the above enclosures to the **controlling officer concerned (DHS/DIMS)** by Hand Delivery so as to reach that office before **03.30 pm on 25.06.2011. Due to time constraints candidates are required to submit the applications in person or through a representative. Applications through post shall be avoided.** The controlling officer concerned will not be responsible for any postal delay. Late and defective applications will be summarily rejected. Candidates should ensure that application has reached the concerned section of the office of the controlling officer.

The DHS/DIMS will prepare a rank list of eligible candidates and forward the same to the Director of Medical Education. The rank list will be made available in the website "www.dme.kerala.gov.in" on **27.06.2011. The selection and allotment of seats** will be made by the DME through a Centralized Allotment Process on 27.06.2011 at 11.30 a.m.
