## Notification

The first round allotment process of the PG Medical (MD/MS/Diploma) Courses 2011 is scheduled to be held from 05.04.2011 to 11.04.2011 in the Directorate of Medical Education, situated in the Thiruvananthapuram Medical College campus. Candidates included in the different reservation categories are also required to attend the counseling on the basis of their rank in the general category. The allotment for candidates other than service quota will be based on the ranklist, which are likely to be published by the Commissioner for Entrance Examinations (CEE) after 29<sup>th</sup> of March 2011.

Candidates wishing to attend the counseling will have to download the prescribed format of preference form from the website "www.dme.kerala.gov.in". Candidates are required to fill in the college and course, which they would like to opt, in the preference form at the time of allotment.

Candidates can opt only for that course/college to which vacancy exists at the time of counseling. Only candidates who have appeared for the  $\mathbf{1}^{st}$  round counseling will be eligible to appear for the  $\mathbf{2}^{nd}$  round allotment.

Selection will be based on the rank secured in the entrance examination and availability of seats. If a candidate is not able to attend the allotment process on genuine grounds, the parent/guardian, or any authorised person can act as proxy at the risk of the candidate. Such authorised person should produce an authorisation letter as mentioned in the Prospectus. Candidates have to produce the admit card of the entrance examination and the original certificates as mentioned in the Prospectus. In the case of candidates, who had already secured admission in a Medical College under AIQ, documents substantiating their admission in that college have to be produced in lieu of the original certificates.

Candidates who get selection in the counseling are required to report before the concerned college on 19.04.2011.
