ORDER

As per Government Order read as 1st paper above, Government have issued guidelines regarding compulsory bonded posting of graduate and post graduate level doctors. As per letter read as 2nd paper above the Director of Health Services has informed that many doctors who got appointment as Assistant Surgeon are applying for extension of joining time for completing their postgraduate courses and to do the Compulsory Rural Service. Their requests have been granted so as to enable them to complete the course. After completion of the course they are bound to join duty under Director of Health Services. But most of them have been posted by the Director of Medical Education in Government Medical Colleges as part of compulsory bonded service. This resulted in scarcity of doctors in hospitals under the Director of Health Services. Hence he has requested Government to give necessary instruction to the Director of Medical Education to relieve such doctors immediately and to stop this kind of posting in future.

In the circumstances Government order that Director of Medical Education shall relieve all doctors who got appointment as Assistant Surgeon and working in Government Medical Colleges as part of the compulsory bonded posting immediately. Such doctors need not be posted under Director of Medical Education as part of Compulsory Bonded Scheme infuture.

Similarly those doctors who were advised by Kerala Public Service Commission for appointment as Assistant Surgeons under Director of Health Services, but had got extension of joining time for doing/completing P.G. degree/diploma course (including in the subjects of Anaesthesiology and Radio

diagnosis) will not be posted for Compulsory Rural Service under Director of Medical Education. They shall be relieved from the Medical Colleges on completion of the course, for taking regular posting in Health Services department. However, if any doctor wishes to relinquish/resign from the post in Health Services, such doctors will be permitted to do so on submitting written application to Director of Health Services and will be allowed to do Compulsory Rural Service posting under Director of Medical Education (for P.G. degree holders and P.G Diploma holders in Anaesthesiology and Radio diagnosis only) and under Director of Health Services for P.G. Diploma holders.
