ORDER

As per the Government Order read as first and second paper above, Government have stipulated that compulsory bonded /rural Service is mandatory to the Medical Graduates /Post Graduates and Dental Post Graduates in the state after the completion of the course. As per letters read as second paper above, Director of Medical Education has reported that there are dearth of faculties in many Dental Specialties in Government Dental Colleges and Medical Colleges in the state. Hence the Director of Medical Education has requested Government to accord sanction for posting them against sanctioned post of Lecturers and Assistant Professors which are lying vacant.

Government have examined the matter in detail and are pleased to order that the Dental Post Graduates who have successfully completed the course shall be posted against the vacant post of Lecturers and Assistant Professors (for the posts of dental faculties only) with a consolidated pay of Rs. 23,000/- (Rupees Twenty Three Thousand only) per month for a period of one year or till regular hands join duty through Kerala Public Service Commission, whichever is earlier. Postings shall be done on the basis of necessity in respective disciplines as per Dental Council of India Regulations. The salary to the appointees shall be met from the Head of Account for the wages to teachers in Dental wing.

All those who cannot be accommodated due to the non availability of vacant post shall be relieved immediately as directed in the Government letter read as fourth paper above.
