ORDER

As per the Government Orders read above, Government have issued guidelines regarding the Compulsory bonded posting of Graduate and Post Graduate level doctors. As per this, the State Mission Director, NRHM is the authority to issue posting orders to Graduate level doctors after obtaining the list of CRRRI completed doctors from Government Medical Colleges as well as Co- Operative Medical Colleges. The State Mission Director has reported that many of the doctors under Compulsory Rural Service go on unauthorized absence and have not completed their bonded obligation Hence he has requested for formal orders from Government to initiate action against the defaulters.

Government have examined the case in detail and are pleased to issue the following guidelines in the matter.

- (i) The State Mission Director, NRHM is entrusted to serve Notice to CRS doctors on unauthorized absence through the District Collectors concerned for initiating action against them vide Rule U/s 144 (2) of the Criminal Procedure Code and to recover the bond amount from the defaulters through Revenue Recovery Act.
- (ii) The CRS doctors who get regular appointment under Government of Kerala, Union Territory of Lakshadweep and Government of India shall be exempted from Compulsory Rural Service.

The State Mission Director, NRHM will issue relieving orders to such doctors on production of the copy of the appointment orders and other relevant documents in this regard. The matter shall be intimated to the Director of Medical Education and the Principals concerned in due course. On receipt of the same the Director of Medical Education shall issue orders exempting such doctors from bonded obligation and intimate the matter to Government and the State Mission Director, NRHM.

- (iii) The State Mission Director, NRHM shall consider the transfer requests from CRS doctors on merit and also as per the conditions stipulated in the Government Order read as 2nd paper above.
