ORDER

As per the Government Order read above, Government have approved the Prospectus for Post Graduate Medical Super Specialty Admission 2010-11. Some of the Clauses in the Prospectus were challenged before the Hon'ble High Court by certain candidates filing Writ Petitions. On the basis of the Interim Order of the Hon'ble High Court read as second paper above, the Prospectus has been modified as per the Government Order read as third paper above. Then the State has filed an Affidavit before the Hon'ble High Court for getting permission to amend the Prospectus by setting apart 10% of the total seats available under general merit to those candidates who had done one year Government service in Kerala. The Hon'ble High Court in its Interim Order read as Fifth paper above has ordered as follows:-

“The pendency of these writ petitions would not stand in the way of the Government taking any steps acceptable to the petitioners for redressing their grievances. If the Government are satisfied that the amendment proposed in IA No.10405/2010 in WP(C)14908/2010 are valid in Law it is open to them to implement the same also subject to the contentions of the petitioners. I make it clear that I have not considered the validity of the proposal on merit and it would be open to them to challenge the same it does not work out to their advantage.”

In the circumstances, Clause III (a) (iii) and Clause V of the Prospectus for Post Graduate Medical Superspecialty courses 2010 is amended in the following manner:

Clause III (a) (iii):

“ The candidates who have done one year compulsory Rural Service/ Senior Residency / Government Service in any of the Government Medical Colleges / Government Hospitals in Kerala will get preference for admission to the seats set apart for them in this regard (10% of total seats available under General merit)

Clause V. Distribution of Seats
