Sub : MES – Establishment – Proposed Medical College at Manjeri – Filling up of the posts of faculties – reg

As you are aware, it is expected that the proposed Medical College at Manjeri, Malappuram will be functional in the next academic year (2013-14) itself. The MCI Inspection in the Institution is also expecting shortly. For this purpose, posts required for the 1<sup>st</sup> phase have been created as per the Govt. Order cited. Details of the faculty posts to be created are enclosed to this communication as Annexure. It has been decided to fill up the faculty posts as detailed below:

1. If any of the existing Principals of Govt. Medical Colleges are willing to be posted as Principal of Medical College, Manjeri, he/she will be posted there. If no willingness is available, the faculties in the cadre of Professor in Medical Education Service and having required experience as per MCI norms and who are willing to work as Principal, Medical College, Manjeri will be considered for promotion and posting. If more than one person is willing to be considered so, the senior most in the cadre of Medical Education Service subject to eligibility will be considered.
2. If Professors in the concerned Departments in Medical Education Service is willing to be posted to Manjeri, they will be posted and if the candidates willing so is more than the

number of sanctioned posts, posting will be made on the basis of the seniority in the cadre of the Medical Education Service.

3. If professors in the Department in Medical Education Service are not willing, then the Associate Professor (cadre) in the Department having required experience for posting as Professors as per MCI norms and those are willing to work at Manjeri will be promoted and posted there. If more candidates than the sanctioned posts in any of the department, then promotion and postings will be made on the basis of the seniority in the cadre of Associate Professors in Medical Education Service.
4. The posts of Associate Professors will be filled up from the faculties in the cadre of Associate Professors in Medical Education Service if candidates willing to be posted there is available. If more candidates than the posts are available posting will be on the basis of the seniority in the cadre of Associate Professor in Medical Education Service. If candidates willing to be posted are available from among the Associate Professors, then the faculties in the cadre of Assistant Professor with required experience as per MCI norms for posting as Associate professor and those who are willing to be posted at Manjeri will be promoted and posted there. If more candidates are available as above, the promotion and posting will be made on the basis of the seniority in the cadre of Assistant Professor in Medical Education Service.
5. The posts of Assistant Professor will be filled up from among the faculties in the cadre in Medical Education Service and those who are willing to be posted there. If more candidates than the posts are willing, then the posting will be made on the basis of the seniority in the cadre in Medical Education Service.

For the above purpose willingness of the faculties are required urgently in view of the short time limit left for completing the process. I am therefore to request you to circulate this communication among the faculties and obtain and forward the list of candidates, those who are willing to be posted at Manjeri as detailed above along with the willingness tendered by the faculties so as to receive the same in this Office by **19.04.2013**. The time limit should be followed invariably and at the same time each of the faculty under your control should be informed of the position to avoid further complaints. The Principals of Govt. Medical Colleges will be held responsible if such a complaint is received.

A reply in this regard should be furnished to this Office by 19.04.2013, even if willing candidates are not available, stating that all the faculties under your control has been informed of the postings and nobody is willing to be posted as detailed above at Manjeri, against the posts sanctioned.

Kindly arrange to co-operate by furnishing the details following the timelimit to ensure the time limit prescribed to this end by Government.
