The Principal of each college will prepare a list of candidates appearing from their college in the serial order of Reg.No. of candidates and send it to the Chairman in the new application form along with filled hall ticket and chalan receipt. Attested copy of the Mark List of D.Pharm Part I Examinations where the candidate has attempted previously should also be submitted along with the application form (In the case of Supplementary Candidates). Principals are requested to obtain application form and hall ticket from the office of the Directorate of Medical Education, Thiruvananthapuram.
