**ORDER**

As per Government Order read as 1<sup>st</sup> paper above, Government have approved the Prospectus for the Post Graduate Medical Degree/Diploma Courses for the academic year 2015-16. Later the Hon'ble Supreme Court of India has ordered the schedule for the completion of the admission process. As per the Schedule June 10<sup>th</sup> is the last date for the completion of admission process under State Quota. Government as per the order read as 3<sup>rd</sup> paper above has amended the Clause 11.1.1 so as to conduct a third round of manual counseling for which the Commissioner. for Entrance Examination issued Notification read above and conducted the third round of allotment during 1-3 of June 2015.

Now, Government are in receipt of representations from candidates who attended the third round of counseling. The Specific complaint is that the candidates who got allotment in the first and second round of allotment were not allowed to surrender their seats during 3<sup>rd</sup> allotment and this resulted in holding of seats of least preference by the Complainants.

Government have examined the matter in detail in the light of the Schedule fixed by the Hon'ble Supreme Court and are pleased to order the following:

The Director of Medical Education will notify and give wide publicity that there will be a Spot Admission on 9<sup>th</sup> of June 2015 and those candidates who wish to surrender their seats in Government Medical Colleges shall furnish a Written resignation letter to the Principal of the allotted Government Medical Colleges before 12 noon on 08.06.2015.

The College authorities shall report the details of such surrendered seats to the Director of Medical Education at 3 p.m on 08.06.2015.

The Director of Medical Education in turn will publish the details of such seats available for Spot Admission in the Website at 5 p.m on 08.06.2015.


No surrender applications will be entertained beyond the above stipulated schedule.
