The allotment will be based on the rank lists published by CEE and availability of seats and as per prospectus condition.

- 3) Those candidates who have discontinued the course after joining.

If a candidate is not able to attend the allotment process, the parent/guardian or any authorised person can act as proxy at the risk of the candidate. Such authorised person should produce an authorisation letter in the prescribed format which can be downloaded from the website. Candidates have to produce the admit card of the entrance examination and the certificates as mentioned in the Prospectus. Candidates who do not submit either original or provisional certificate to prove their PG Degree qualification at the time of counseling will not be considered for the allotment. Candidates who have taken admission in the 1<sup>st</sup> round counseling should produce the possession certificate from the respective college.
