Medical Education Service – Establishment- Promotion of Staff Nurse Grade II to the cadre of Staff Nurse Gr. I - Sanctioned- Orders issued.

ORDER No.J2/26811/2011/DME Dated: 08.03.2016

As per this office order read as 1st paper above, the seniority list of Staff Nurse Gr.II as on 31.12.2011 under Medical Education Services was finalised. Later several complaints were received from incumbents working as Staff Nurse Gr.II to rectify the defects in the seniority list such as correction of wrong seniority assignment, non-inclusion of name etc. Accordingly as per order read as 4th paper above the seniority list is revised and modified vide this office order read as 1st paper above. On the basis of revised seniority list of Staff Nurse Grade II, the incumbents whose seniority position is rearranged / who are newly included in the list as shown in the list appended to this order is eligible for promotion as Staff Nurse Gr.I in the existing vacancy. At present there are 75 vacancies of Staff Nurse Gr.I due to promotion as Head Nurse.

2. Smt. Suma.K.S, Rank No.549 in the seniority list was given promotion with effect from 20.11.2014 as per this office order No J2/26811/2014/DME dated: 03/12/2014. Later the same was cancelled as per order No. J2/26811/2014/DME dated: 23/02/2015 due to an erroneous leave (LWA) report from the Superintendent, Govt. T.D. Medical College Hospital, Alappuzha. Originally the incumbent on LWA was Smt. Suma.K.S. with rank No.1012 whereas, Smt. Suma.K.S, with Rank No.549 was continuing in service at Medical College, Kottayam. Now Smt. Suma.K.S, with Rank No.549 has requested to restore her promotion as Staff Nurse Gr.I with effect from 20.11.2014 as per representation read as 6th paper above and she is therefore retrospectively promoted as Staff Nurse Gr.I with effect from 20.11.2014. Also Smt. Suma.K.S, the other candidate with rank No.1012 has re-joined duty as Staff Nurse Gr.II with effect from 28.01.2016. As such the incumbent is eligible for promotion as Staff Nurse Gr.I in the existing vacancy after the date of re-joining duty.

3. Smt. Bini.M.K, Rank No.775 was wrongly promoted as Staff Nurse Gr.I with effect from 20.11.2014 while she was continuing on Leave Without Allowances. Now she re- joined duty as Staff Nurse Gr.II with effect from.03.10.2015 FN at Medical College, Kozhikode. The wrong promotion granted to her with effect from 20.11.2014 is therefore reviewed and cancelled on retrospective effect. She is eligible for promotion as Staff Nurse Gr.I in the existing vacancy after the date of re- joining duty i.e., 03.10.2015.

4. As per this office order read as 2nd paper above, the Staff Nurses Gr.II up to the rank of 1199 were promoted as Staff Nurse Gr.I. Hence the Staff Nurses Gr.II from Rank No.1200 are eligible for promotion as Staff Nurse Gr.I in the existing vacancies.

5. In the case of Staff Nurse Gr.II, who are on Leave Without Allowances but promoted by mistake to the cadre of Staff Nurse Gr.I, the promotions will be reviewed and cancelled. The Principal or Controlling Officer concerned should report such cases to this office immediately for further necessary action.

6. All Principal of Medical Colleges/ Dental Colleges and Superintendents/ Medical Officers of Medical College Hospitals and allied institutions are directed to communicate the copy of this order to the promotes who are working under their administrative control.

7. The head of institution/ custodian of service records in respect of incumbents should verify the date of birth, date of commencement of service and rank position with seniority list of Staff Nurse Gr.II and satisfy themselves about genuiness of the promotions. Any discrepancies noted should be reported to this office with connected details without fail. Necessary entries regarding promotion in respect of incumbents should be entered in the Service Book with proper authentication.

8. Under the above mentioned circumstances, the Staff Nurses Gr.II as per the list appended to this order are promoted as Staff Nurse Gr.I with effect from the date noted against their names in the scale of Pay of Rs.14620-25280 (Pre-revised). On promotion the incumbents are permitted to continue in the present station since the posts of Staff Nurse Gr.II and Staff Nurse Gr.I are interchangeable.

9. The Promotions will be reviewed subsequently if found necessary. The arrears of pay and allowances will be governed as per G.O (P) No.515/2007/Fin Dated: 19.10.2007.
