The seniority list of L.D.Clerks of this department as on 6/12/2010 was finalized, as per this office order read as 3<sup>rd</sup> paper above. Aggrieved by this, Sri.Bedimon.S and others filed WP® No.1870/2011 in Hon'ble High Court on the reason that the seniority list has been finalized by treating them as inter district transferees though they were shifted to this department from Health Services Department, by option, on abolition of Dual Control System and without considering the objection filed by them against the provisional seniority list.

- 2. The Hon'ble High Court has disposed of the above Writ Petition in the light of the fact that the petitioners have got an effective remedy under rule 27-B of KS & SSRs to challenge the final seniority list before Government without prejudice to the right of the petitioners to invoke the said remedy.
- 3. Government, in their letter read as 5<sup>th</sup> paper above, have directed to publish the present combined seniority list of L.D.Clerks in this department as draft list and to invite objections in three weeks and finalise it immediately in compliance with the judgment read 4<sup>th</sup> above.
- 4. In view of the circumstances explained above, the seniority list of L.D.Clerks as on 6/12/2010 finalised vide order read above is published as provisional and appended to this order.
- 5. The aggrieved persons will file appeals through Principals concerned with documental evidences to substantiate the claim on or before 29/02/2012.
