MES - Estt-Fixation of ratio between Staff Nurse Grade I and Grade II under Medical Education Services - sanctioned-orders issued

Read: - 1) G.O(P)No.85/2011/Fin., Dated: 26/02/2011

ORDER No.J2/26811/2014/DME Dated:20/11/2014

Due to abolition of dual control system in Government Medical College and allied Hospitals of the State, the administrative control of nursing staffs vested with the director of Health Services were transferred to Director of Medical Education and the appointment, seniority, promotion etc of Staff Nurses / Head Nurses etc were need to be conducted separately. At present no ratio is maintained between Staff Nurse Grade I and Grade II / Staff Nurses Grade I and Head Nurse under Medical Education Services. As per Para 5 of the G.O read as 1st paper above, Govt. issued orders that the revised / existing ratio /percentage based promotions will come in to effect from 01/02/2011 and the same will continue unless otherwise it is modified. In Annexe XII (55) of the above said order it is ordered that the existing ratio of 1:1 between Staff Nurse Grade I and Staff Nurse Grade II posts will continue. Also the existing ratio of 1:2 between Head Nurse and Staff Nurse Grade I will continue.

At present there are 2269 Staff Nurses and 550 Head Nurses in this Department. To fix the ratio of 1:1 between Staff Nurse Grade I and Staff Nurse Grade II and 2:1 between Head Nurse and Staff Nurse Grade I, the number of Staff Nurses is to be reduced to 2256 (Grade I-1128 & GradeII-1128) where as the number of Head Nurses is to be increased to 563. So 13 (Thirteen) posts of Staff Nurses need to be upgraded as Head Nurse for which necessary permission orders of Government is required.

Under the above mentioned circumstances, sanction is accorded to fix

the ratio of 1:1 between Staff Nurse Grade I and Staff Nurse Grade II as per the provisions contained in the G.O. read as 1st paper above; as detailed below.
