

PROCEEDINGS OF THE DIRECTOR OF MEDICAL EDUCATION, THIRUVANANTHAPURAM

Medical Education Service – Establishment- Promotion of Staff Nurse Grade II to the cadre of Staff Nurse Gr. I and cancellation of erroneous promotions - Orders issued.

As per this office order read as 1st paper above, the seniority list of Staff Nurse Gr.II as on 31.12.2011 under Medical Education Services was finalised. As per orders read as 2nd & 3rd papers above, the Staff Nurse Gr.II under Medical Education Services were promoted as Staff Nurse Gr.I according to their seniority in the entry cadre of Staff Nurse Gr.II. On further verification the following staff Nurses promoted as Staff Nurse Gr.I are on Leave Without Allowances and hence their promotions are reviewed.

2. In the above mentioned circumstances, the promotion as Staff Nurse Gr.I sanctioned to the above mentioned incumbents as per order read as 2nd paper above is cancelled herewith. The eligible incumbents in the above list for promotion as Staff Nurse Gr.I on the date on which they re-joined duty are promoted as shown below.

3. Smt. Anchu.P.S, Staff Nurse, Govt. T.D. Medical College, Alappuzha, Rank No.1154 (A) in the seniority list was given promotion as Staff Nurse Gr.I with effect from 20.01.2015 as per order read 3rd paper above. But her immediate seniors and juniors were promoted with effect from 23.01.2015. Hence the date of effect of promotion of Smt. Anchu.P.S is reviewed and revised as 23.01.2015.

In the case of Staff Nurse Gr.II, who are on Leave Without Allowances/ non declaration of probation but promoted by mistake to the cadre of Staff Nurse Gr.I, the promotions will be reviewed and cancelled. The Principal or Controlling Officer concerned should report such cases to this office immediately for further necessary action.

5. All Principal of Medical Colleges/ Dental Colleges and Superintendents/ Medical Officers of Medical College Hospitals and allied institutions are directed to communicate the copy of this order to the promotees who are working under their administrative control.

6. The head of institution/ custodian of service records in respect of incumbents should verify the date of birth, date of commencement of service and rank position with seniority list of Staff Nurse Gr.II and satisfy themselves about genuineness of the promotions. Any discrepancies noted should be reported to this office with connected details without fail. Necessary entries regarding promotion in respect of incumbents should be entered in the Service Book with proper authentication.

7. As per this office order read as 3rd paper above, the Staff Nurses Gr.II up to the rank No. 1234 were promoted as Staff Nurse Gr.I. Hence the following Staff Nurses Gr.II from Rank No.1235 and other eligible Staff Nurse Gr.II, who re-joined duty after LWA are promoted as Staff Nurse Gr.I with effect from the date noted against their names in the scale of Pay of Rs.29200-62400 (Revised) in the existing vacancies. On promotion the incumbents are permitted to continue in the present station since the posts of Staff Nurse Gr.II and Staff Nurse Gr.I are interchangeable.
