Smt.Sindhu.T.M was appointed as L.D Clerk under Compassionate Employment Scheme as per G.O (Rt) No: 2363/92/H&FWD dated:26.09.1992 and posted as per this Office Order No: E1-25755/92/DME dated: 09.10.1992. She joined duty in the Fore Noon of 19.10.1992. She joined duty in the Fore Noon of 19.10.1992. She was declared to have satisfactorily completed probation in the post of L.D Clerk with effect from the Fore Noon of 06.11.1994. She passed Departmental Test of M.O.P held during June 1995 and Account Test (Higher) during 07/ 2003. She was assigned rank No: 20 in the seniority list of L.D Clerks of Medical Education Department published as on 01.02.2000.

2. As per this Office Order No: E1-10008/2000/DME dtd: 12.06.2002, Sri.Dinesh Kumar whose rank number in the above seniority list of L.D Clerks is 21 and who is the immediate junior to Smt.Sindhu.T.M was promoted as U.D Clerk with effect from 01.05.2002. Being a member of Scheduled Caste Community, she was eligible for temporary exemption from passing the departmental tests for promotion under Rule 13 A(1) (a) of KS&SSRs. Though she was eligible to get promotion as U.D Clerk against the vacancy that arose on 01/05/2002, she was not promoted under Rule 13A (1) (a) of KS&SSRs. But, she got promotion as U.D Clerk with effect from

06.01.2004, as per this Office Order No: E1-10008/2000/DME dated: 20.03.2004, only after passing the Account Test held during June 2003. She was assigned rank No: (78) in the Combined Seniority list of U.D Clerks published as on 01.09.2010 as per order 1st referred to.

3. have clarified Circular No: Government clearly in 8130/Adv.C3/2010/P&ARD dated: 24.02.2012 that the employees belonging to SC/ST category and entered in public service on or after 01.01.1986 and whose probation in the category declared to have satisfactorily completed but not acquired the departmental test qualification for promotion are eligible for temporary exemption from passing the test for 3 years and to give them promotion on the due date of promotion as if they had passed the tests in due time under Rule 13 (A) (1) (a) and as per the conditions specified in Rule 13 A (2) of KS&SSRs. It is also instructed there in that in the cases where such benefit is not given earlier, the same are to be re-examined on receipt of applications and to give them seniority and promotion.

4. Smt.Sindhu.T.M, Senior Clerk, Govt. Medical College, Alappuzha as per representation dtd: 22.03.2012 has requested to give her promotion as Senior Clerk with effect from 12.06.2002, the date on which she was actually entitled for promotion, with all consequential benefits.

5. After being examined the matter in detail in the light of relevant Rules in KS&SSRs, Smt.Sindhu.T.M, Senior Clerk, Govt. Medical College, Alappuzha was given notional promotion to the cadre of Senior Clerk with effect from 01.05.2002, the date on which her immediate junior ie., Sri.Dinesh Kumar was promoted as U.D Clerk, under Rule 13A (1) (a), as per this Office Order 2nd referred to, as she was found eligible. It was also ordered there in that her seniority in the cadre of Senior Clerk based on the notional promotion will be decided separately.

6. In view of the promotion granted notionally with effect from 01.05.2002, the incumbent is eligible to get seniority in the list of Senior Clerks as on 01.09.2010 in between SI.No: 60 (Smt.Suseela.K.G) and SI.No: 61 (Sri.Dinesh Kumar.G).

7. It is, therefore provisionally decided to assign rank No: 60 A to Smt.Sindhu.T.M, Senior Clerk, Govt. Medical College, Alappuzha in the combined final seniority list of Senior Clerks as on 01.09.2010 published as per this Office Order 1st referred to.

8. Any persons aggrieved of the above assignment of rank may file appeals, if any, within 3 (three) weeks from the date of receipt of this Notice. If no appeals are received within the time stipulated, the above decision will be confirmed.
