As per Pay Revision order 2019 read as 1st paper above, 25% of total number of Senior Superintendents/ Lay Secretary & Treasures are eligible for ratio/percentage based Higher Grade in the Scale of Pay of Rs. 56500-118100.

Total number of posts in the cadre of Senior Superintendent under this department is 42. Hence ten senior most Senior Superintendents are eligible for ratio/percentage based Higher Grade at a given time. As per order read as 3rd and 4th paper above, two Senior Superintendents, who were granted ratio/percentage based Higher Grade have been promoted to the cadre of Accounts Officer and one got promoted as Administrative Assistant. Accordingly, as per the order read as 1st paper above, three Senior Superintendents are eligible for Higher grade.

The Hon'ble High Court of Kerala in the judgement dated 13/03/2019 in W.A.No. 1418/2010, W.A.No. 1525/2010, W.A.No. 1527/2010, W.A.No. 1652/2010 have directed that the seniority of the optees shall be determined with reference to the proviso to Rule 27(a) of Part II KS &SSRs and the inter seniority list finalized. The Hon'ble Supreme Court of India in the order dated 17/04/2019 in the SPL(CIVIL) Diary. No(s) 11684/2019 ordered to maintain the status quo, in so far as seniority of the respective parties until further orders.

In compliance with the order of the Hon'ble Supreme Court, maintaining the status quo, the following next eligible Senior Superintendents who were holding the post are granted the ratio based Higher Grade promotion in the Scale of Pay Rs. 56500-118100, allowable from the seniority list read as 2nd paper above, against the vacancies that arose as detailed below.
