Both of the above complaints has been scrutinised and it is found that, the Provisional seniority list has been prepared based on the DPC select list. There is no interim orders issued by the Hon'ble Administrative Tribunal, in OA(EKM) 1234/2017 & OA(EKM) 1599/2018 to review the existing select list. Therefore, there is no legal impediment in publishing and finalising the seniority list in the cadre of Associate Professor, Department of Prosthodontics.
