The provisional Seniority list of faculties in the cadre of Associate Professor, Department of Prosthodontics, under Medical Education Service has been published, as per the circular read as 3rd paper above. The last date for submitting complaints, if any, was on 31/03/2022.

Dr.Vinni T K, Associate Professor in Prosthodontics, Government Dental College, Kozhikode, (Sl. No. 2), as per her representation read as 4th paper above, has informed that, Dr. Induraj is not legally entitled for seniority above her in the category of Assistant Professor and also Associate Professor in the Department of Prosthodontics. The revision of the select list in the category of Assistant Professor, Prosthodontics for the year 2015 in the Kerala Dental Education Service, by the DPC during the pendency of O.P(KAT) No.101/2021, before the Division Bench of the Hon'ble High Court, is totally arbitrary, and unfair. Hence, she has requested that, the inter seniority dispute between Dr. Indu Raj and her (Dr Vinni T K), be finalized only after the disposal of O.P(KAT) No.101/2021 by the Hon'ble High Court and Promotion to the post of Professor of Prosthodontics to be done only after the final disposal of the case.

The matter has been verified in detail, and it is noticed that, in the representation of Dr. Vinni.T.K, it is stated that, the Hon'ble High Court have partly heard the case. As there is PG Course in the Govt. Dental College, Kottayam, it is necessary to fill up the Professor post at Govt. Dental College, Kottayam, immediately to satisfy the DCI norms and retain the recognition. Therefore, this Department is not in a position to withheld the promotion procedure until the disposal of O.P (KAT) No.101/2021. In the above circumstances, it is decided to finalise the Seniority list of faculties in the cadre of Associate Professor, Department of Prosthodontics, subject to the Final Judgment of the Hon'ble High Court of Kerala in O.P (KAT) No.101/2021.

Dr. Indu Raj, Associate Professor, Government Dental College, Kottayam (Sl. No. 1), as per her representation read as 5th paper above, has requested that, the petition, if any, received against the Provisional seniority list now published, may be disposed of only after hearing her.

Her request may be considered, as and when, the final Judgment issued by the Hon'ble

High Court of Kerala in O.P (KAT) No.101/2021, and if any change in her seniority position in the provisional seniority list published as per this office circular 3rd read above.

As such, the provisional Seniority list in the cadre of Associate Professor, Department of Prosthodontics published, as per this office circular 3rd read above is hereby finalised, subject to final order of the Hon'ble High Court of Kerala, in OP (KAT) 101/2021.
