Sub:- CEE-Allotment/Admission to MBBS/BDS courses 2017-compliance to the orders of the Hon'ble High Court dated 22.08.2017-request to participate in the admission procedure- reg.

- Ref:- 1) Orders of Hon'ble High Court dated 22.08.2017 on WP(C) No. 22117/2017(L) and connected cases.
2) This office notification of even no. dated 25.08.2017

As per the reference (1) above, the Hon'ble High Court has ordered to conduct one more online counseling to MBBS/BDS courses on 27.08.2017 and to complete the admission proceedings on 28th & 29th of August 2017. As directed by the Hon'ble Court, the admission procedure shall be done in the **Old Auditorium inside Government Medical College Campus, Thiruvananthapuram** on 28th & 29th of August 2017 for which all the Medical/Dental college authorities shall have to be present at this venue.

The Hon'ble High Court has also ordered that the vacant seats remaining after 4 pm on 29.08.2017 shall be filled up through Spot Admission to be held on 30th and 31st of August 2017 in the same venue. Accordingly, Spot Admission to fill up the vacant seats in MBBS/BDS courses shall be done on **30th and 31st of August 2017** in the above venue.

In the circumstances, I am to request that the Principals of all the Medical/Dental Institutions in Kerala or a person authorized by him who is competent enough to complete the admission procedure or to issue Transfer Certificates and other documents to students who are admitted in any of the courses in the institution for joining MBBS/BDS courses may please be present in the **Old Auditorium inside Government Medical College Campus, Thiruvananthapuram** from **28.08.2017 to 31.08.2017 (4 days)** for completing the admission procedure so as to comply with the orders of the Hon'ble Court.

I am also to inform you that any violation in this regard shall invite contempt of court procedures.
