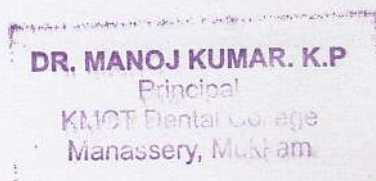
Therefore we request you to kindly make an allotment from among the NEET qualified candidates who are not registered with CEE to fill the above mentioned vacant seats.
